

Transportation Priorities Plan

Agreement to Participate

The City of Sacramento is gathering stories, as part of its *Transportation Priorities Plan*, regarding the experiences of younger community members traveling around their neighborhoods and throughout the city, including photos, videos, artwork, poetry, short stories, or other creative formats (“creative submissions”).

Participants under 18 years of age must have permission from a parent or legal guardian before sending any creative submission to the City of Sacramento’s *Transportation Priorities Plan*. No exceptions.

Consent to Publish and Use Creative Submissions:

I, Participant or Participant’s legal guardian, hereby grant and assign to the City of Sacramento the non-exclusive right and world-wide royalty free and perpetual license to perform, publish, display, distribute, or otherwise use any creative submission provided by the Participant, individually or in conjunction with other original artwork, writing, poem(s), photos, video, or other creative content provided to the City of Sacramento for any purpose whatsoever, and to sublicense to third parties these same rights. I represent and warrant that the creative submission(s) submitted are the original work of the Participant and such work does not infringe upon the rights of any third party.

Consent to Use Participant’s Information:

I, Participant or Participant’s legal guardian, consent to the use of Participant’s name, Participant’s likeness in picture, video, or audio recording, and Participant’s geographic location (city and state/country) to identify the creator of the creative submission. I understand that any use of any creative submission may include the Participant’s name as its creator and the City and State where the Participant resides, and may also include an identifiable likeness of the Participant in picture, video, or sound recording; and I hereby give consent for the publication and use of this personal information, and consent to such use without compensation of any kind for the Participant or myself, other than the privilege of participation in the *Transportation Priorities Plan*.

Agreement to Release Rights

I, Participant or Participant’s legal guardian, hereby release and discharge the City of Sacramento from any and all claims and demands arising out of or in connection with the use of Participant’s creative submission, name, likeness, or location, including without limitation any and all claims for libel or invasion of privacy. This release shall be binding upon the Participant, myself, and our heirs, legal representatives, and assigns. I further release the City of Sacramento from any responsibility for any injury incurred during the research or production of the creative submission. This authorization and release shall also inure to the benefit of the successors, legal representatives, licensees, and assigns of the City of Sacramento.

The City of Sacramento assumes no responsibility for lost or damaged creative submissions and will not return creative submissions. The City of Sacramento may assign, license, or otherwise transfer all rights granted to it hereunder.

Social Media

The City of Sacramento’s social media sites are not intended for the use of children under the age of eighteen (18). I understand that if I, Participant or Participant’s legal guardian, choose to connect one or more of social media accounts with the City of Sacramento’s social media accounts to enable the sharing of personal data or creative submissions via social media platforms, certain categories of Participant’s creative submission, name, likeness, or location, data relating to such social media account(s) will be shared with the City of Sacramento.

Withdrawn Consent

I, Participant or Participant’s legal guardian, understand that I have the right at any time to withdraw my agreement and consent by directly emailing the City of Sacramento at VHermanson@cityofsacramento.org. I understand that I may withdraw consent and agreement at any time in the future, but where Participant’s creative submission, name, likeness, or location, has already been made public, withdrawn consent will not apply.

Electronic Signatures

I, Participant or Participant’s legal guardian, hereby agree that any electronic signature indicating agreement with the terms of this Permission to Participate form is the same as a handwritten signature for the purpose of validity, enforceability, and admissibility.

Agreement and Verification:

I, Participant or Participant’s legal guardian, hereby agree that I have read the foregoing and fully understand the contents thereof. I, Participant or Participant’s legal guardian, hereby agree to the terms stated above on behalf of the Participant, Participant’s heirs, legal representatives, successors, and assigns.
